The British Medical Association (BMA), British Dental Association (BDA) and Hospital Consultants and Specialists Association (HCSA) have announced 120 hours of continuous junior doctors' strike action from 07:00 on **Thursday 13** July until 07:00 on **Tuesday 18 July**. The BMA and BDA has announced that consultant doctors and dentists will be taking strike action for 48 hours from 07:00 on **Thursday 20 July** until 07:00 on **Saturday 22 July**

#### Industrial Action Update- Messages for Providers

- The Humber and North Yorkshire Integrated Care Board (ICB) will also stand up and manage a dedicated Incident Control Centre (ICC) over the imminent period of Industrial Action between 13 July-22 July. Care providers are advised to contact the ICC in the event of a serious incident resulting in significant harm to residents or service users that relates to the industrial action so that intelligence can be gathered at ICB level. The number to call for Humber and North Yorkshire ICC is 0300 002 0007
- For providers that have the service in place, we are encouraging providers to please use the Immedicare Telemedicine service where appropriate for any non-urgent non 999 situations, to help support services in prioritising calls requiring an emergency response. You are likely to receive quicker access to clinical support over this period by using the Immedicare Service where you have it in place. A document is available giving examples of when Immedicare can be used versus calling 999 or your GP Practice. It's important that staff are familiar with how to use the service when required and we would encourage homes to support new starters in accessing training. A 5 minute training video is available on the clinical laptop itself, or Immedicare are able to provide either face to face or virtual training as needed.
- Regardless of any strike action taking place, it is really important that people who need urgent medical care continue to come forward as normal, especially in emergency and life-threatening cases when someone is seriously ill or injured, or their life is at risk.







## **Guidance and Information Update**

#### Give your Views: Learning Disability and Autism Training for Health and Social Care Workers

The government want to hear your views about guidance covering learning disability and autism training for people who work in health and social care. The Oliver McGowan code of practice sets out how providers of health and social care can make sure their staff receive learning disability and autism training suitable for their role. What you tell the Department of Health and Social Care (DHSC) about the code of practice will help shape the final version of the code. The code of practice is named after Oliver McGowan, whose tragic death in 2016 highlighted failures in care that could have been prevented. We believe that it is essential that autistic people and people with a learning disability have access to safe, high-quality care. We have worked with DHSC to shape this code of practice

#### Adult Social Care Nurse Leadership Programme- NY+Y

Skills for Care has developed this programme to support registered nurses working in social care (who are in a leadership role) develop their leadership practice and enhance their personal and professional impact when managing teams. The programme is made up of five interactive workshops covering a range of leadership concepts and theories. These will enable participants to develop the required knowledge and skills to enhance their leadership practice when working across complex and often challenging systems. There will be presentations, discussions, and exercises to take part in, including 360 appraisals and work-based projects to embed learning and further support the development of leadership and management skills. We're offering 20 funded places to organisations based in York and North Yorkshire as well as a backfill payment of £1000 per participant to employers.

## **Shingles Vaccination Programme Changes**

The letter outlining the changes to the shingles vaccine programme from 1 September 2023 has been published <u>here</u>, which also contains a useful eligibility table. Those who can receive the vaccine, being expanded to younger age groups so individuals, particularly those with a weakened immune system, can be protected at an earlier age to prevent more shingles cases. It means hundreds of thousands more people will be able to get protected against shingles each year.

The vaccine that is used in the programme is also changing. All newly eligible individuals will be offered two doses of the non-live vaccine Shingrix instead of the live vaccine Zostavax.

From 1 September 2023:

- Those aged 70-79 who were previously eligible (prior to 01/09/23) will continue to be eligible for the shingles vaccine from their GP practice. This cohort will be offered one dose of Zostavax until the stock is depleted and then two doses of Shingrix (6 to 12 months apart) thereafter.
- all those aged 50 and over with a weakened immune system will be offered two doses of the Shingrix vaccine by their GP practice (8 weeks to 6 months apart)

# **Current Studies**

**Safer Online Lives** - This study aims to evaluate the use of the internet & social media by people with Intellectual Disabilities. The study will survey 100 people with Intellectual Disabilities (ID) to investigate their online positive experiences and the risks they take while online. Separate questionnaires will also be sent to family carers, paid carers and safeguarding practitioners to also look at their experiences supporting people with ID, who use the internet. From the 100 people surveyed approximately 20 adults with ID (10 women, 10 men) for in depth analysis and understanding of their online experiences. A further 30 will be observed investigating the ways people with ID use the internet and the safety steps they take while online. ## The Background

#### **Double Shortlisting Success for Nursing Team in 2023 Nursing Times Awards**

# HARA commissioning arrangements

- Process is only to be used for people in receipt of the Funded Nursing Care or full Continuing Healthcare funding i.e. not people in receipt of residential care only. For those homes that provide both nursing and residential care please note that requests for residential go via the community nursing team as this process is managed by Harrogate and District Foundation NHS Trust
- When you place a request to the Home Delivery Service for a nursing resident if you do not provide the
  person's NHS number the request will be rejected
- Containment products are a prescribed product and therefore there should be no sharing of products between residents





# Patient Reviews and HDS online

#### Update patient assessments on HDS Online:

- HDS online requires care homes to input the recording of reviews to ensure that they still require the products that have been prescribed and that those products are meeting their needs.
- To record a review:
- 1 Find the patient's record and click the Clinical tab
- 2 Click Edit at the bottom of the page
- 3 Click the calendar alongside the Assessment date box and select the date that the review took place
- 4 Select the name of the Assessor from the drop-down list
- 5 Click Save changes. A message is displayed if the record is successfully saved.
- If you do not have access to HDS Online you can complete the attached "New User request form" with the persons
  details and send back to <u>home.delivery@supplychain.nhs.uk</u> and they will then create the account and send an
  email to the person you have made the request for. Any questions relating to this please contact the same email
