Group Consultation Training- Free to Attend

A small number of team places funded by NHS England for group consultation training on 22 May are available.

Practices must field a full team to qualify for a place (details are in the attached application form). This is because when the full team attends, it maximises chances of successful mobilisation.



HCA Apprenticeship Scheme and GPN Ready Scheme

Please find via the following links, HEE information packs detailing this year's <u>'HCA Ready Scheme'</u> and <u>'GPN Ready Scheme'</u> for expressions of interest. The schemes are a great opportunity to receive funding and support the employment and training of an apprentice HCA, a newly-qualified nurse or a return-to-practice nurse.

HCA Ready Scheme (HCA Apprenticeship Scheme)

Now in its fifth year, another cohort of this scheme will be starting in September 2019.

- Receive a bursary of £6,800 to support your practice in recruiting and employing an apprentice HCA, and to cover the apprenticeship levy contribution.
- Includes a fully funded programme of study days and 'bolt-on' clinical training modules.
- HCAs completing the apprenticeship will gain a Level 3 Diploma in Healthcare Support, Level 2 English and Maths and the Care Certificate. The apprenticeship provider will be Connect2Care.
- Full details and conditions can be found in the attached information pack.

GPN Ready Scheme

Now in its fourth year, the GPN Ready scheme will be available again from September 2019.

- Receive up to £8,000 in funding; comprising of a bursary of £3,000 to support in recruitment and employment, and up to £5,000 for education and training of a newly-qualified nurse or a return-to-practice nurse.

Flying with an insulin pump or CGM?

Medical Device Awareness Card

A new Medical Device Awareness Card has been launched, sponsored by the Civil Aviation Authority (CAA) and Airport Operators Association (AOA), which covers insulin pumps, CGMs and flash glucose monitoring devices including the Freestyle Libre. Due to potential damage, insulin pump and CGM manufacturers advise that the medical devices should not be exposed to x-ray screening or full-body airport scanners. Regulations allow passengers with these medical devices to ask for an alternative security screening process. The new card provides information for both the Security Officer and the passenger and can be downloaded directly from the <u>CAA website</u>.

Campaign Organiser, Rachel Humphrey has had passport sized (8.5cm x 12.5cm) versions of the card printed and is providing them free of charge upon receipt of a stamped addressed envelope (UK only). For details please <u>email</u> or follow this <u>link</u>.

RCN Foundation Professional Bursary Scheme

The RCN Foundation Professional Bursary Scheme offers grants of up to £5,000 per year for career development and CPD activities in the following areas:

- Primary care nursing (up to £5,000)
- Long term/chronic conditions (up to £5,000)
- History of nursing (previously the Monica Baly Bursary Scheme) (up to £1,000)
- Occupational Health Nursing in Scotland (previously the Mair Scholarship Scheme) & the rest of the UK (up to £1,000)

Applicants must be able to detail how their course will improve patient care in their field.

To be eligible for a grant the following criteria must be fulfilled:

- UK Registered Nurses and Midwives
- · Health care support workers working in the UK
- Nursing Associates
- Course start date must fall between 1 September 2019 and 1 September 2020

The training is designed to provide practitioners with the latest evidence based knowledge to be able to confidently advise on, and undertake cervical samples. The basic training programme spans 1½ days and covers topics
