Flu Vaccination for Health and Social Care Workers

Having the flu vaccination every year is important, but this year it is vital to make sure we do all we can to support and protect the NHS and care services due to the potential impact of flu and COVID-19 circulating at the same time.

Flu can be deadly and is easily spread from person-to-person, even amongst those not showing any symptoms. Unvaccinated and asymptomatic, but nevertheless infected, staff may unknowingly pass the virus on to vulnerable residents, friends, family and colleagues.

Flu outbreaks can have a serious effect on the social care sector. Every year there are flu outbreaks in care homes despite high flu vaccination rates for

residents. This is partly because as people age, they do not produce as good an immune response to vaccinations. The vaccination against flu protects the people we care for and protects staff, their family and friends, helping to keep services running safely during winter.

How can I support staff flu vaccinations?

If you are a manager, Public Health England produces resources specifically for those working in the social care sector and you can access these <u>here.</u>

Please help the fight against the flu virus this year by encouraging your team and colleagues to book their flu vaccination.

If you're a frontline health and social care worker, your employer should offer you a flu vaccine. They may give the vaccine at your workplace. Ask your employer how they will be offering staff the flu vaccine this year.

You can also have the flu vaccine if you provide health or social care through <u>direct payments or personal health budgets</u>, or both. The <u>NHS website</u> has more information.

PPE Portal: How to order COVID-19 PPE and Ordering Changes

Eligible health and social care providers can order PPE through the portal to meet the increased need that has arisen as a result of the COVID-19 pandemic. This <u>updated guidance</u> gives information regarding the increased order limit information for all sectors to reflect recent increases and has removed order information on type II masks.

The order limits for different types and sizes of eligible health and social care providers are listed within the guidance these are kept under review to make sure they reflect the latest public health guidance, COVID-19 demand modelling and analysis.

The PPE portal can be used by social care and primary care providers to get critical coronavirus (COVID-19) personal protective equipment (PPE). You can only log in and place an order if you've received an email invitation to register. The PPE portal can be used by:

- GPs
- residential social care providers
- domiciliary social care providers

(and others)

If you're a provider in one of these categories, your invitation to register will be sent to your email account registered with Care Quality Commission (CQC), NHS Business Services Authority (BSA), NHS England or the Medicines and Healthcare products Regulatory Agency (MHRA).

PPE ordered from the portal is free of charge and will be delivered by Royal Mail within 4 days.

Eligible health and social care providers can use the portal to meet the extra need for PPE that has arisen as a direct result of the COVID-19 pandemic. You should not use the portal to order PPE for non-COVID-19 requirements. You should get this through your normal channels.

Eligible providers can now use the portal to order PPE for COVID-19 requirements, rather than as an emergency top-up system. There have also been some other updates including:

- domiciliary care providers with 50 or more clients and residential care homes with over 50 or more beds can now order one box of visors (usually 200 per box) per week
- added type II masks to the list of items that can be ordered
- updated order limits for GPs and social care providers.

PRINCIPLE Study- Help the Fight Against COVID-19
