NHS Standard Contract for Care Homes and Domiciliary Care Providers

All Care Homes and Domiciliary Care Providers in the Vale of York should have received an email from the Contracting Team at the CCG to inform them that it is the CCG's intention to establish the NHS Standard Contract with all Providers in the Vale of York area.

To compile the contract documentation the following documents/policies (where applicable) are required. It is requested that copies of the following documents are forwarded to the CCG by **Wednesday 14 October 2020**:

- Evidence of CQC Registration
- Employers' Liability/ Public Insurance Documents
- Safeguarding Policies
- Incident Reporting Policies
- Transfer and Discharge from Care Policy
- Medicines Management Policy

Capacity Tracker- New Questions

Care homes registered with the capacity tracker will have received an update around new questions that will be launched on the tracker on **Wednesday 14 October.** The 3 questions added are as below, and are designed to help understand any issues providers may be having around these topics on a national and local level.

- How many staff and residents are known to have had a flu vaccination
- Where there may be issues accessing flu vaccinations
- The COVID19 status of residents received from NHS Trust hospitals.

In addition there will also be 2 surveys, these only need to be completed **once.**

- Survey 1 'Syringe Pumps' (to be completed by Nursing homes only):
- Survey 2 'Proxy Medicine Ordering' (to be completed by All Care Homes)

The Courage of Compassion- Supporting Nurses and Midwives to Deliver High-Quality Care

The Kings Fund have published a report aim to showing how to transform nurses' and midwives' workplaces so that they can thrive and flourish and are better able to provide the compassionate, high-quality care that they and those they serve wish them to deliver. The report examines the workplace stressors, organisational cultures, working contexts and leadership styles that impact on nurse and midwife wellbeing and mental health, both before and during Covid-19. It sets out how these can be changed to provide dramatically improved working environments and contexts for nursing and midwifery practice, thereby benefiting nurses, midwives, patients, women, families and communities.

The report's scope covers all areas of practice and all care settings where nursing and midwifery staff operate, including primary care, secondary care, mental health, community care and social care. PRINCIPLE Study- Help the Fight Against COVID-19
