Please ask staff individually complete the form and booking on the following the link that has been circulated to homes. They will need to know their own GP, their NHS number and car reg. As always to avoid the risk of covid transmission – Do not car share unless absolutely necessary – then use face masks, and passenger sit at the rear

Nimbuscare federation is providing this service on behalf of the city practices. This means unfortunately it is not available for staff registered outside of these practices.

For staff registered with other GP Practices, please be patient, we have communicated with all GP Practices to ensure you are able to book a vaccine with them. Please contact your practice direct. Community pharmacies are now also able to reorder supplies, so may be able to take bookings shortly.

In all circumstances your vaccine should be free and no provider whether it is a community pharmacy or GP practice should be requesting payment.

NHS researchers in Leeds, Harrogate and York are working together to help find a vaccine for COVID-19. We are recruiting now for the next stage of clinical trials to help find a vaccine. Together with the National Institute for Health Research, we have put together an animation to explain the process of vaccine research.

To better understand the effectiveness of vaccine candidates and help find a vaccine that works for as many people as soon as possible, researchers are particularly seeking more volunteers from Black, Asian and minority ethnic backgrounds as well as those with underlying health conditions and the over 65s.

# Capacity Tracker- Updated IPC Questions

A review has taken place on questions on the tracker which are required to be updated to access the IPC fund. This review has meant that some existing questions have been removed, some have been re-worded and some new questions have also been added. These are expected to be live on the tracker from Monday 9 November

The new questions cover the following areas:

- Limiting the use of public transport by members of staff
- Staff choosing to stay separately from their families
- Residents receiving visitors
- Regular weekly testing of staff for COVID-19

The majority of the questions form part of a weekly submission for Care Homes and Hospice Providers with a number requiring an update on a monthly basis only. All providers are required to review and update responses to the questions each week/month and to confirm this has been done. Thank you for everyone's really hard work so far in submitting their information via Capacity Tracker, rest assured all the information you provide is reviewed daily and used to support collective planning across the health and social care sector both locally and nationally to swiftly resolve issues wherever possible, whether through local or national actions

## Why Hypothermia is a Bad Sign in Infections

Often, a systemic infection like sepsis will cause a patient to develop a high fever as part of the body's immune system response. In some cases, though, a patient will develop hypothermia, or low body temperature instead.

When an individual develops hypothermia during sepsis, there is an increased risk of fatality than when a patient develops a fever. The reason body temperature can change is the body normally "resets" itself at a higher preferred temperature and begins to expend energy keeping the body warmer as a means of fighting infection. When this does not happen or when the body resets at a colder temperature, the body is at a disadvantage because decreased blood flow and circulation already occurs with blood vessel dilation with sepsis, and cold temperature further decreases this blood flow. Although further research is needed, hypothermia during sepsis can be indicative of larger immune system problems and an ominous course.

Health Education England have produced a <u>resource</u> on Systemic Inflammatory Response Syndrome (SIRS) (of which sepsis is one such cause) — where hypothermia is one of the recognized features to look out for (in addition to tachycardia, tachypnoea or low blood pressure.
