### **Your Request for Information**

I am writing in response to your recent request that we received on 28 September 2020 in which you requested the following information under the Freedom of Information Act 2000.

### **Information Requested**

- What alternative arrangements for Structured Diabetes Education programmes have been commissioned/put in place by the CCG to support people living with diabetes due to the COVID-19 pandemic (e.g. virtual delivery via video conferencing tools, digital etc)?
- With the recent NHS primary care reorganisation, which organisation (if not your organisation) within your STP/ICS footprint is responsible for the commissioning of Structured Diabetes Education programmes for people living with diabetes?
- Could you provide contact details for the main person responsible for commissioning Structured Diabetes Education programmes for people living with diabetes?
