

Development of 'Safeguarding at a distance' guidance for primary care


Guidance for management of Initial and Review Health Assessments

Work with HDFT LAC team to identify and support children placed out of area who were not receiving statutory health assessments

Working with NHS E to ensure information about local domestic abuse resources is available at testing sites




Our Partners in Care

Infection prevention and control - COVID specific training and testing

- 100% of care homes trained = 401 staff from all care settings
- 874 tests taken at local Pillar 1 test site plus many more in care settings



Digital support

- Tablet devices for virtual consultations issued to 73 care settings
- NHS mail and secure LA mail provided to 127 of 143 care providers
- Capacity Tracker embedded by 78 / 80 providers

£1million capital funding from NHS England into City of York Council's new short breaks service to facilitate intensive therapeutic short breaks for children within the scope of the Transforming Care Project.



Significant improvements in both access times and recovery rates in IAPT services. During the year the service based itself alongside a number of member practices, providing greater access for patients and professionals.

Adult mental health

Access to Early Intervention for Psychosis is now delivering well beyond the national target.

NHS Continuing Healthcare



We achieved significant improvements in NHS Continuing Healthcare decisions completed within 28 days of referral.


We met all our targets for assessing more people outside a hospital setting enabling people to have a period of recuperation and recovery in the community before determining their long term healthcare and support needs.

We implemented personalised support plans and training across the system so people who were eligible for Fast Track Pathway funding received more personalised end of life care.

Personal health budgets

We increased the number of people who had a personal health budget by five fold to give more people more choice and control over their care.

The CCG was selected as a mentor site to support other CCGs across the country to offer personal health budgets as the default delivery model for NHS Continuing Healthcare.
