Second Dose of COVID Vaccination for Care Home Staff

There have been a number of enquiries recently regarding access to second dose vaccinations by social care workers. We would like to reassure staff that there will be options for vaccination made at a local level and agreed between your Care Home Manager and Care Homes Vaccination Team through the GP Practice

- The Care Home Manager will be asked by the vaccination team to provide numbers of staff to be vaccinated at the same time the vaccination team visits your care setting for residents also;
- Numbers of staff who will require vaccination by attendance at the Askham Bar Vaccination site

This aims to reduce footfall within the home on vaccination day and allow for workforce planning. This approach also allows for the vaccination teams to plan accurate supply, appointments and staffing. If a Care Home Manager has not received notification of a visit within 10 weeks of the 12 week window please contact the Vaccination Team via the GP Practice.

Due to national supplies being centrally controlled this means there are limited opportunities for flexibility in appointments.

The Vaccinations Teams appreciate your patience and support in ensuring your whole home are vaccinated in a timely manner.

Diabetes Medication Stock Reminder

In the last month there have been some serious incidents relating to residents with diabetes. These have included residents not receiving oral medication or insulin as required. All diabetic medication as you appreciate is time critical and in one incident insulin could not be administered at the right time due to there being no stock available when the vial being used was identified as out of date.

District Nurse colleagues would like to ask that all care homes ensure that residents have sufficient stock of medications, particularly for those with diabetes. The Head of Nursing – Community will ensure the DN teams make you aware of expiry dates for opened insulin to enable further stock to be ordered without the need to stock pile, but that will prevent delays in your residents care.

Capacity Tracker Updates

- Capturing second dose of COVID vaccination: this information will be captured in the Capacity Tracker from mid-April 2021.
- Enhanced Provider Access: Work has commenced that will give enhanced access to the reports that are available within the Capacity Tracker. This will give providers the visibility of their organisation's information compared with consolidated information of comparable organizations. This is intended to share information collected from providers during the pandemic in a useful way that can support organizations understand both their information in a wider context as well as support benchmarking. More details will follow over the next few weeks.
- Workforce Absence within Business Continuity for Care Homes and Hospices: the collection of absence data for workforce contained within the daily business continuity has been slightly modified following feedback from providers.

The subtle change is to reflect that those staff 'not on shift' should no longer be recorded in the non-covid absence field. This should now only capture those members of staff that should be at work but are unable to due to non-related COVID absences such as non-covid sickness, maternity leave or furlough. Providers should no longer record staff not on shift within this part of their daily business continuity return.
