#### NHS Mail Help Video for Care Providers and Update

To help you and your staff in using these accounts, we have created a brand new video guide which you can refer to as needed. This is broken into easy to find sections, covering why NHS Mail is needed, what is should be used for, how to access your homes shared mailbox and much more.

Health services are now in the process of making the transition to using NHS Mail exclusively where possible to communicate securely with care providers,

beginning with GP practices, mental health services and continuing healthcare with further services to follow. This is because regular care provider email systems do not meet the security level required to send and receive information of this nature. They will be primarily using the "shared mailboxes" which are usually in the format <a href="mailto:care.VABCD@nhs.net">care.VABCD@nhs.net</a> and all NHS mail users from each home will be able to access from their individual NHS Mail account.

It's important that all homes have sufficient staff set up with access to communicate with the health services, and most homes have now been contacted about this. Where helpful we are able to visit homes to assist if needed.

CQC Strategy 2021

CQC have launched their new strategy which has been shaped contributions from the public, service providers and partners organisations. This means their regulation will be more relevant to the way care is now delivered, more flexible to manage risk and uncertainty, and will enable them to respond in a quicker and more proportionate way as the health and care environment continues to evolve. ## Partners in Care Virtual Forum: Carers of people with dementia – Support and Information Needs'

The Partners in Care Virtual Forum will take place this week on 3 June 2021 at 2.00-2.45. This time Professor Sue Ziebland and Dr Suzanne Li (from the Universities of Oxford and York, funded by the NIHR School for Social Care Research) will be attending as a part of project developing new online service improvement resources, featuring people talking about their own experience of care. They have created a 9 minute Catalyst film on 'Carers of people with dementia – support and information needs', which they will be showing and inviting comments from care providers on at the forum. The catalyst film, along with many other service and public facing resources for social care will be published on a new platform for social care resources (to be called SocialCareTalk.org) later this year. They would like to hear what you think about the potential to use this type of resource in social care. #### **Funding to Support Functional Skills for All Care Workers**

Health Education England (HEE) recently announced that funding for software to support functional skills has now been extended to all social care providers. The software can help people to improve their own skills in maths (numeracy), English (literacy) and IT (digital skills). It can be used to study towards a functional skills exam (e.g. for enrolling onto an apprenticeship), to generally improve competence and confidence, and for job satisfaction and retention. #### New Award to Recognise Exceptional Practice in Adult Social Care Workforce

A new set of awards have been launched by the government to recognise the outstanding contribution made by social care workers and nurses in England and their enormous range of skills, expertise and enduring compassion. The awards will be on an application basis and awarded throughout the year. Nominations will be considered by a panel of NHS and adult social care chief nursing officers and adult social care sector representatives. The Chief Nurse for Adult Social Care aims to present the first award later this year. These could be awarded to either an individual or a team. The awards will not be limited to registered nurses and will be extended to include all carers across all care settings, not only care homes. Applications are available for the gold award and silver award which should be supported by 2 signatories:

#### Yorkshire Ambulance Service Dementia Friendly Strategy

YAS has made a commitment to become a Dementia Friendly organisation as part of its Clinical Strategy (2019-2024). Information on how they are working towards this can be found in these slides at a recent Partners in Care Virtual Forum. This includes training of staff and innovative CPD opportunities including a dementia bus and sessions delivered by dementia champions, as well as making documentation dementia friendly. They have received 123 dementia patient friendly patient transport vehicles, and engaging with dementia awareness groups and health professionals/services involved in the care of those with dementia to get their views.
