Track and Trace Data on Capacity Tracker

From the evening of **Monday 16 August 2021**, Care Homes and Home Care providers will be able to view their own testing data within the Capacity Tracker. A DHSC pilot provided Adult Social Care managers with visibility of their testing. This resulted in 92% of managers taking meaningful action to encourage staff testing, leading to an increase in the number of registrations for both PCR and LFTs across the pilot settings. It is hoped that sharing this information wider with all Care Home and Home Care providers will help build on this success.

The Test and Trace data imported into Capacity Tracker is based on the number of registrations that have been recorded within the NHS Test and Trace system that have also included a Unique Organisation Number (UON). To ensure all

information is accurately captured and aligned to a provider, Care Home and Home Care staff are asked to continue supplying their UON details when registering test kits for their organisations via <u>Register test kits for your</u> <u>organisation - GOV.UK (test-for-coronavirus.service.gov.uk)</u> (PCR tests) or <u>https://www.gov.uk/report-covid19-result</u> (lateral flow tests)

In addition, ALL Capacity Tracker registered users will now be able to view aggregate Test and Trace statistics on either a National, Regional, or more localised level via the Capacity Tracker reports function. This will enable all providers and health and social care professionals to review their own setting/area and make comparisons with other areas etc. Further guidance on how to use the Capacity Tracker Test and Trace Statistics report will be posted on the <u>Resource Centre</u> on the evening of Monday 16 August 2021

COVID Vaccinations as a Condition of Employment in Care Homes- Guidance, Resources and Webinar

The government has published it's full <u>guidance</u> on how care homes will be required to manage vaccination of staff and visiting professionals (such as maintenance workers and entertainers. CQC have produced parallel <u>guidance</u> on how this will be enforced.

The Department of Health and Social Care has worked with Skills for Care to provide <u>additional resources</u>, to help care home managers and providers prepare for the new regulations. This includes a social media graphic with the key policy dates, a Q&A, vaccine communications toolkit and materials to support workforce capacity planning, recruitment, and retention.

COVID Vaccination in Pregnancy

Since the 16 April the Joint Committee on Immunisations and Vaccinations has recommended that pregnant women should be offered either the Pfizer or Moderna vaccine. Any pregnant staff should already be supported in conversations relating to encouragement of the vaccine as part of their antenatal care, but there are also a series of posters and guidance available through Public Health England which may be useful to support you in any discussions you are having with any pregnant staff who remain vaccine hesitant.

This PHE guidance which is written for women to read prior to vaccination can be found through this <u>link</u>, which states:

"The Joint Committee on Vaccination and Immunisation (JCVI) has advised that pregnant women should be offered COVID-19 vaccines at the same time as people of the same age or risk group. In the USA, around 90,000 pregnant women have been vaccinated mainly with Pfizer and Moderna vaccines and no safety concerns have been identified.

Evidence on COVID-19 vaccines is being continuously reviewed by the World Health Organization and the regulatory bodies in the UK, USA, Canada and Europe. Pfizer and Moderna vaccines are the preferred vaccines for pregnant women of any age who are coming for their first dose. Anyone who has already started vaccination and is offered a second dose whilst pregnant, should have a second dose with the same vaccine unless they had a serious side effect after the first dose"

Webinars: Responding To Vaccine Hesitancy/Building Confidence – Further Dates Arranged

Following on from a series of workshops that have taken place over the last couple of months, Public Health England have arranged 3 further workshops focusing on responding to vaccine hesitancy as they have proven very popular. These may be helpful for providers in having conversations/building confidence in the vaccine amongst your staff.

This skills training is based on Making Every Contact Count (MECC), which is important skill that can be utilised to combat disinformation and myths and whilst providing the necessary reassurance and confidence in what is a safe and effective vaccine. The session will be interactive and include modelled conversations that showcase the core skills and processes being used. The application of this work can be farreaching. Although this is focused on the Covid vaccination programme, these skills can be utilised for the flu vaccine, cancer screening and other healthpromoting activities.
