#### **Extension of PPE Portal and Consultation**

The portal for free PPE for social care providers has been extended to March 2022. Full details are available through this <u>link</u>.

DHSC have launched a consultation on continuing this service beyond this time. Responses are welcomed from across the sector to help the Government make a well-balanced and considered decision, to comment please follow this <u>link</u>. **To note:** From Monday 4 October 2021, the new phone number for emergency PPE requests will be: 0800 876 6802 (lines open Mon-Sun 7am-7pm). The National Supply Disruption Response line (0800 915 9964) remains in use to report disruptions to any medical products."

# Guidance on Medical Exemption from COVID-19 Vaccination and Capacity Tracker Reporting

DHSC have published <u>guidance</u> on how people can apply for official proof that, for medical reasons, they are unable to be vaccinated and/or tested for COVID-19. All exemptions will be confirmed by a doctor, specialist clinician or midwife. If approved, the <u>NHS COVID Pass</u> can then be used by an individual to prove their status

The possible reasons for exemptions are limited, and include:

• People receiving end of life care where vaccination is not in the person's best interests

• People with learning disabilities or autistic individuals, or people with a combination of impairments where vaccination cannot be provided through reasonable adjustments

• A person with severe allergies to all currently available vaccines

• Those who have had an adverse reaction to the first dose (for example, myocarditis)

• Short-term exemptions will also be available for those with short-term medical conditions and as an option that some pregnant women may choose to take. Exemptions for pregnant women will expire 16 weeks post-partum, in order to allow them to become fully vaccinated after birth.

To assist in recording exemptions, from **7 October 2021** Care Homes will be asked to update their Covid vaccination information within Capacity Tracker for numbers of staff with a medical exemption certificate. They will also be asked to record the numbers of staff that have received a Covid vaccination abroad e.g. Janssen vaccination.

If you think you have been sent kits that have already expired, then please send an email with a photo attached of expiry dates on the box, the packet and the vial to <u>carehometesting@dhsc.gov.uk</u>.
