#### Flu Pack for Care Homes

Please find through this link below a pack of flu resources from Public Health England. This is to help homes detect outbreaks of influenza-like illness promptly, notify them to the Yorkshire and Humber Health Protection Team (HPT) and undertake immediate action to minimise transmission within the care/residential home.

#### **HCV Resilience Hub Bereavement Support**

#### **Research Opportunity- Contact Pilot**

# Playlist for Life- Using Personal Playlists to Support Those with Dementia

At last weeks Partners in Care we heard about the power personal music playlists can have for those living with dementia, benefits of which can include all of the below.

- Can help people connect and reunite families
- Recall memories or abilities
- Restore a sense of self
- Help manage mood
- Reduce need for psychotropic medication
- Improved nutritional intake
- Improved continence
- Reduction in falls

- Reduction in use of restraint
- Making difficult tasks easier (e.g. personal care)

#### **Funding Now Available for Essential Training**

Skills for Care have recently confirmed that fully funded Essential training is now available. This training is available as three individual packages of learning:

- Rapid induction (aimed at new staff)
- Refresher training (aimed at existing staff)
- A volunteer programme.

Their aim is to help employers quickly train new recruits to ensure that all workers can complete their duties safely. Employers can select from 12 endorsed training providers, some of which are new additions this year. These providers have been awarded grants to deliver the rapid induction programme. # Guidance on Medical Exemption from COVID-19 Vaccination and Capacity Tracker Reporting

DHSC have published <u>guidance</u> on how people can apply for official proof that, for medical reasons, they are unable to be vaccinated and/or tested for COVID-19. All exemptions will be confirmed by a doctor, specialist clinician or midwife. If approved, the <u>NHS COVID Pass</u> can then be used by an individual to prove their status

The possible reasons for exemptions are limited, and include:

- People receiving end of life care where vaccination is not in the person's best interests
- People with learning disabilities or autistic individuals, or people with a combination of impairments where vaccination cannot be provided through reasonable adjustments
- A person with severe allergies to all currently available vaccines
- Those who have had an adverse reaction to the first dose (for example, myocarditis)



# Extension of PPE Portal and Consultation

The portal for free PPE for social care providers has been extended to March 2022. Full details are available through this link. DHSC have launched a consultation on continuing this service beyond this time. Responses are welcomed from across the sector to help the Government make a well-balanced and considered decision, to comment please follow this link.

• Short-term exemptions will also be available for those with short-term medical conditions and as an option that some pregnant women may choose to take. Exemptions for pregnant women will expire 16 weeks post-partum, in order to allow them to become fully vaccinated after birth.
