

Capacity Tracker- Beds Available versus Vacant Beds

To improve accuracy of reporting, The Capacity Tracker have changes planned so that care homes can report on both available and vacant beds. Until this has been implemented, they are asking that providers enter the number of
available beds in the vacancies box. For example If a provider has five empty beds but for whatever reason can only fill three of them then the number of 'vacancies' will be three. If the providers has 60 beds, and there are 3 vacancies then that shows 2 beds are unable to be admitted to at present.

Partners in Care LD and Autism Forum

We will be holding our be having our second Partners in Care LD and Autism Provider Forum this week on **Wednesday 20 October 2.00-2.45**. Gill Thomas, Clinical Lead Nurse for the Community Learning Disability Team (Tees, Esk and Wear Valleys NHS Foundation Trust) will be coming along for discuss what their service is, the criteria, referral and what support they can offer providers around behaviour that challenges whether that is low level nursing support or looking at PBS (positive behaviour support)

Following feedback from the first forum, this session will be designed **solely** for care providers to help provide peer support and raising of issues/challenges to help us support you as a sector. Domiciliary Eyecare Guidance

New guidance has been published from the Primary Eyecare Sector's Domiciliary Eyecare Committee. This guidance covers how they will meet the needs of people who are unable to leave home unaided owing to physical or mental illness or disability are potentially at higher risk of eye disease and vision problems than the general population. PALS Service Update

The Patient Advice and Liaison Service (PALS) at York and Scarborough Teaching Hospitals NHS Foundation Trust has seen a marked increase in calls from patients who tell us that their GP has advised them to call PALS. PALS can help if a concern relates to care a patient or loved one is receiving or has received. We aim to respond within two working days, but it may take a little longer at very busy times. If the concern is about any of the following issues please direct to the relevant team directly rather than via PALS.

Issue	Advice / Contact
Waiting for appointment/unsure when your appointment is?	The Covid-19 pandemic has had a huge impact on service delivery across the NHS and there are delays as a result. Please call the Contact Centre on 01904 726400 The contact centre team is best placed to advise you about your appointment.
Unable to get through to a ward	We know this is a worrying time and are aware of the challenges when visiting is restricted due the pandemic. Please persevere and try the ward again later. PALS does not have an alternative number to ring and we are unable to put calls through to wards. If you do not have the ward number please contact Switchboard on 01904 631313
If your query relates to being on a waiting list	Please contact the Waiting List Team directly to discuss your concerns if you have the number or Switchboard will be able to put you through to the relevant team.
If you have a query about test results	Please contact the team looking after you or your GP as they are best placed to discuss your results with you and agree next steps.

Fire Safety in Care Homes

The National Fire Chiefs Council have created guidance for providers on fire safety in care homes and nursing homes to support with current health and safety practices. The guidance emphasises the critical importance of staffing levels, emergency plans, and fire safety management arrangements in Care/Nursing Homes. They recommend providers find their local Fire Risk Assessors or Local Fire and Rescue Service to support with reviewing your fire risk assessments and management arrangements.

How to Make the Most of Student Nurse Placements

With the help of practitioners from the workforce and input from people who need care and support, Skills for Care have launched a guide which supports the understanding of nursing placements within social care settings. This is the first time such guidance has been produced following funding from Health Education England. It's a quick and easy way for employers to identify what type of experience your setting can offer to a student nurse and how it maps to the nursing curriculum (future nurse standards of proficiency) by using the 10 descriptions of different social care settings included in the guide. This gives you a fantastic opportunity to not only develop your training offer but also develop your staff by encouraging them to think about how they could support student nurses in the workplace.
