#### NHS COVID Pass Verifier- App Now Available on CCG Tablets

The NHS COVID Pass Verifier App is now available on CCG tablets, and can provide secure way to scan an individual's NHS COVID Pass and check that they have been fully vaccinated against COVID-19, had a negative test, or have recovered from COVID-19. To add the app onto your tablets you will need to clear the **"F4IT"** button where it will be available to install. #### **Urgent Care Practitioner Service**

Please find through this <u>link</u> a poster that care homes are able to print and display detailing the support that is available through the UCP service. The service operates between 7.00 and 23.00 and can visit for a resident with minor injuries or related

concerns. You might like to consider calling the UCP desk as an alternative to calling 999 in some circumstances where your patient has minor injuries but is not an emergency. Urgent Care Practitioners (UCPs) can assess your patient as below, can provide a range of medication and direct admission to a ward where appropriate.

- Musculoskeletal assessment of joints
- Muscular back pain
- Witnessed and unwitnessed falls without obvious fractures and severe hip pain, where conscious and alert as normal.

Treatment of underlying minor illnesses that have caused Injury- Such as a UTI causing a fall

• Head injuries with or without wounds, where not on anti-coagulants.

• Glue, steristrips and suturing for skin tears and wounds.



#### International Stop the Pressure Day- 18 November 2021

We are encouraging providers to raise awareness of the dangers of pressure damage in their services to mark International Stop the Pressure Day, and have pulled together a <u>bulletin</u> which gives some suggestions of activities you can undertake with your staff and those in your care. moisture and pressure damage. We will also be hearing from two of our care home managers, one of whom will be updating on how the React to Red training programme has provided support in preventing damage and another on how they implemented dietary changes to boost nutrition and reduce the risks of pressure damage.

These sessions are designed to provide support with the latest guidance, updates from across health and social care and a chance to ask questions of both health professionals and fellow care sector colleagues. #### Accessing Flu Vaccination and COVID-19 Booster Vaccination for Frontline Social Care Staff

All those staff with long term conditions or over 50 years of age will automatically be contacted by their GP practice for their flu vaccination. or may book at your local pharmacy. All other staff can access by booking with their local community pharmacy – this should be free for front line staff as long as you take a form of photo ID demonstrating you work in health or social care. For anyone wishing to know more about the Flu Vaccination programme please follow this link. Please do your bit to protect yourself, your family and others who are vulnerable. Protecting ourselves from Flu remains crucial, so please do not delay booking your jab

For COVID-19 boosters, the national booking portal is now live for frontline health and social care staff to book appointment. Staff will only be able to book if 6 months (180 days) have passed since your second dose vaccination, and will be asked to take a form of work ID with them to the appointment. To book please follow this <u>link</u>. If you've had positive COVID-19 test you must wait 4 weeks (28 days) from the date of the test result before booking

#### Revised Guidance for NHS Professionals Visiting Care Homes

A letter has been circulated on behalf of York and Scarborough Teaching Hospitals NHS Foundation Trust and the NHS Vale of York CCG, which details revised guidance for NHS professionals working for the Trust in visiting care homes. This follows strengthened quidance published by The Department of Health and Social Care in order to reduce risks from visits by NHS professionals. We would be grateful for you make your staff aware of the changes which will have now come into place in line with national policy.

The key changes in relation to visiting NHS professionals are that:

• Care homes should see evidence from the professional of a negative rapid lateral flow test within the last 72hrs, which shows If any staff are having any difficulties in accessing vaccines please contact <a href="mailto:sam.varo@nhs.net">sam.varo@nhs.net</a>

they are following the NHS staff testing regime
NHS professionals visiting care homes should be granted entry if they have a negative test result as part of regular weekly staff testing using LAMP technology.

Care homes must ask the NHS professional when they were last tested and see proof of the result and date of the relevant professional's test. Further information on types of proof that are acceptable and a link to the full guidance can be found in the letter, and these <u>slides</u> shown at Partners in Care Virtual Forum last week.

Please also find a <u>letter</u> on behalf of the CCG which details the approach our staff will take to be able to demonstrate proof of vaccination when entering a care home.
