Visiting Professionals Proof of Vaccination for Care Homes-Reminder and Feedback Request

As a reminder, please find this <u>letter</u> which details the 3 methods of which proof of vaccination from a visiting professional can be demonstrated. Homes **must** now check any vaccination status of any professionals visiting the home, and any of these forms of identification **must** be accepted in order to avoid a risk to residents of staff being turned away. For those needing to demonstrate proof it

can be good practice to request a letter demonstrating proof, as a standby in case of any technical issues.

If providers are having any issues with visiting staff showing proof of vaccination, we would really value if this could be fed back for us to escalate as necessary. We would also appreciate any feedback in understand how homes are managing the recording of vaccination status of visiting staff or on any issues you are experiencing around this. Visiting Professionals and Admission of Residents FAQ's for Care Homes

Please find below a set of FAQ's produced by North Yorkshire County Council to answer questions by homes in relation to testing and demonstrating <u>proof of vaccination for visiting professionals</u>, and <u>testing on admission of residents</u>.

Questions answered include:

- How can a visiting professional show proof of their vaccination status?
- What counts as an emergency situation for Vaccination and Testing?
- A Visiting professional has shown me a positive PCR test from the last 90 days, should they retest?
- A resident is going to be readmitted to the home/setting after being in hospital, can we accept them without a test?
- We have a resident returning from hospital following an overnight stay for elective care, do they need to isolate?
- We have a resident being discharged from hospital following admission for emergency care, do they need to isolate?



Stop the Pressure Day- Pressure Ulcers and Moisture Associated Skin Damage: What Am I Looking At?

Discharge Quality Standards Consultation

As circulated last week, all independent care providers are invited to share their views to a shape a new set of discharge standards for the area. These have been created by the North Yorkshire and York Quality of Discharges Group based on available guidance, evidence and contributed too by a wide range of partners, and created following feedback of instances where the quality of discharge has led to a poor experience for the patient and their families and sometimes left the person at risk of harm. These standards are broken down into each step of the discharge journey. We would value your thoughts asking: 'is this the standard we expect and want for the people we care for?'. The standards and a document helping hospital teams discharging to homes are embedded below for your thoughts, and also a script which you can share with for them to provide any comment.

Social Care Talk

The CCG has contributed towards research led by the Universities of Oxford and York which has resulted in the launch of a platform <u>Socialcaretalk.org</u>. This is designed to support individuals in understanding what it's like to navigate the UK social care system, by watching other people share their stories. This website helps to prepare you for what's ahead, beyond the forms and appointments. Socialcaretalk.org is based on academic research into real people's experiences of social care and includes sections on paying for care, dementia and autism among others.

Capacity Tracker Update- Out of Hours Discharges

Please note that from **Monday 22 November**, a field will be added to the "Cost and Vacancies" section for care homes asking to record whether they are able to accept out of hours admissions. This is part of winter resilience measures so health and social care discharge teams can identify homes who are able to support this. If homes would be able to ensure that this box is updated that would be a great help.

Urgent Care Practitioner Service

Please find through this link a poster that care homes are able to print and display detailing the support that is available through the UCP service. The service operates between 7.00 and 23.00 and can visit for a resident with minor injuries or related concerns. You might like to consider calling the UCP desk as an alternative to calling 999 in some circumstances where your patient has minor injuries but is not an emergency. Urgent Care Practitioners (UCPs) can assess your patient as detailed in the poster can provide a range of medication and direct admission to a ward where appropriate.
