Access to COVID Vaccination for Social Care Staff- Reminder and Support

You will be aware of the national push to encourage individuals to have their COVID-19 booster jab (as well as first and second doses for those who have not yet received) to provide optimum protection against the Omricon variant. We know that care providers are doing an excellent job in supporting their staff in accessing vaccination to help protect themselves and those in your care, however we are reaching out to support those who are still needing to access vaccines but are having difficulties in doing so.

As a clarification on for first doses for staff with face to face contact in domiciliary and supported living services, the last date to receive as per guidance is **3 February** to order to be double vaccinated by 1 April. However in order to be 14 days fully vaccinated and the effects of the vaccines to have taken full effect, staff may consider getting their vaccines earlier. We would encourage to staff to get vaccinated at their earliest opportunity in order to get optimum protection.

Vaccine supplies in the area are currently plentiful and can be accessed either through a booked appointment, or through one of the drop in clinics listed through this link (please bring staff ID if accessing this way):
