Social Care Day of Remembrance and Reflection- 17 March 2022

This Thursday will mark the social care day of remembrance and reflection, which is being held by 20 social care organisations including Skills for Care and the Care Workers Charity to tribute to everyone working across social care and remember those we've sadly lost to COVID-19. A virtual memorial wall and tribute wall has been created to share messages dedicated to members of our social care workforce. There will also a <u>virtual event</u> on the day from 10.30-12.30 which will include personal stories, plus the reading of a specially written poem dedicated to

- Evensong Service at York Minster on **Thursday 17 March** at **5.30pm** will be used to mark social care remembrance and reflection day, and include prayers specific to staff from across the sector to mark their contribution during the pandemic. All are welcome who would like to attend and providers encouraged to share the date with their staff.
- A special choral evensong service will also take place at York Minster on **Wednesday 23 March** at **5.30pm** with music and readings chosen especially for the day, to mark two years since the start of the pandemic . The service will be attended by Simon Armitage, the Poet Laureate, and feature the premiere of a new poem as specially commissioned from him by the Chapter of York Minster to mark the National Day of Reflection. Prayers will be said for emergency, frontline and keyworkers at the service. Again all are welcome at the service, further information can be found through this <u>link</u>.

We recognise this will be a challenging and emotional day for many. The <u>HCV</u> <u>Resilience Hub</u> is able to offer confidential and independent advice and support for a range of issues including emotional wellbeing and bereavement. The support they can provide includes developing a wellbeing plan and signposting to resources, as well as access to support groups and wellbeing webinars.



Research Opportunities for Care Providers

At Partners in Care this week we heard from Lizzie Hancock from Fulford Nursing Home who championed how providers can benefit from taking part in research. It can provide new ideas to improve best practice and get a critical eye to challenge ways of working, as well as a great opportunity for staff and residents to get involved. There are a wide range of opportunities available to providers, and care homes are able to join the <u>ENRICH</u> register to automatically notified of news studies. A summary of some the opportunities currently available can be found through this <u>link</u>, which includes:

• Defining and Measuring Safety in Older Adult's Care Homes Survey

• Skyline Study- Recruiting adults age 60+ who are cognitively unimpaired to receive either a study drug or treatment to prevent the onset of Alzheimer's Disease

• ClimaCare Study- Remotely indoor environment and the response of residents and staff in care homes, and sharing advice from international experts on how to improve your resilience in hot weather and heat waves.

Reminder- PPE, Testing and Proof of Vaccination for Visiting Professionals

Though restrictions outside of health and social care have relaxed, please can we take this opportunity to remind providers that all current guidance relating to Covid 19 measures for those providing care remains in place and has not changed, Staff must still comply with all guidance until it is reviewed and this includes wearing appropriate PPE at all times while in a care setting. The requirement to check LFD (or LAMP where appropriate) test results for all those entering care homes remains as does the verification of vaccination status for visiting professionals until guidance is revoked from 15 March. The Omricon variant is still circulating in high numbers across the community and continues to pose a risk to the most vulnerable in our care.

Medequip Complaints Process and Equipment Returns

For any providers wishing to make a complaint about the Medequip Community Equipment Service, you are able to do so by calling 01423 226240 or emailing north.yorks@medequip-uk.com. The service will log the complaint, and ensure that providers receive a timely response. Providers are encouraged to chase with the service should there be a delay, and if they are able to obtain the log/reference number of the complaint, know who they reported it to in MQ, be clear about which service user this in relation to and provide as much detailed information as possible this will ensure their complaint is fully addressed. Should they not be satisfied with the response received are able to escalate to the CCG by contacting sam.varo@nhs.net and supplying the above information. The CCG receive a summary of complaints made into the service which are discussed at regular contract review meetings, to help inform service improvements.

A reminder also that equipment is only for the initial person it was prescribed for and not used by others. To return equipment you can do so using the above contact details and supplying serial number/EIN number. This bulletin is produced by NHS Vale of York Clinical Commissioning Group.
