Discharge Medications Trial

York Teaching Hospital NHS Foundation Trust are trialling a process to assist with their early discharges and the complications involved in early completion of tablets to take out to accompany the patient travelling on PTS transport. This has been underway for a couple of weeks, will continue this week and a further update will be provided following a review of the trial.

This is a model that they have successfully running in other trusts in the North East of England and have significantly improved the early discharges and patient flow. The organisation delivering the service (CIPHER Medical) will be providing a wheelchair accessible vehicle with ambulance care assistant that will deliver patient tablets to take out, if they have not/will not be completed by pharmacy before the patient has been taken home by transport. The service will run 10am until 10pm Monday to Friday. This vehicle also has capacity to take T1 category patients as well as patient medications also some selected equipment. In addition, the service will also be providing a stretcher vehicle available from 10am to facilitate those early stretchers that also may be waiting for medications.

The booking of the tablets to take out to be delivered will be on an electronic booking system. The Discharge Pharmacy Team book all medications on the system and Patient Flow Team book patients. For any queries please contact the hospital discharge team.

CCG Funded Tablets and CLEAR Dementia Care App

The CCG's funded tablet scheme for care homes has been extended an additional 12 months. The scheme has seen tablets allocated to the majority of care homes as well as 8GB of funded data, to allow residents to communicate with loved ones, staff to access training and to allow homes to take part in virtual consultations, MDT's and further digital working. Also now available on provider tablets ins the CLEAR Dementia Care App which provides information about dementia and support for carers, including different types, the brain, symptoms, behaviours and loss. The app also includes a function to help record and chart behaviour, and contains illustrations and case examples to help us to understand the perspective of the person with dementia. To add to your tablet you will need to press the F4IT button, and the app will be showing under the app catalogue to download.

• ClimaCare Study- Remotely indoor environment and the response of residents and staff in care homes, and sharing advice from international experts on how to improve your resilience in hot weather and heat waves.
