Proof of Vaccination and Testing Reminder for Those Visiting Care Homes

A reminder that care providers no longer need to ask visitors for proof of vaccination status. Visiting health professionals will continue to perform regular LFT or LAMP testing, however please note that staff who do not interact with residents such as delivery drivers from Medequip and NRS are not required to test. All visiting staff do however need to ensure good hand and respiratory hygiene (including the use of a fresh mask in the building). The caveat to this

guidance is the situation remains fluid and if we see a rise in cases this may change.



World Continence Week: 20-26 June

This month marks World Continence Week, and the continence team at York and Scarborough Teaching Hospitals NHS Foundation Trust will be holding a series of events across the week relevant to care providers. Capacity Tracker Update- Action for Care Homes

Care homes will have received national communications regarding upcoming changes to vacancy information on the Capacity Tracker, to make information more precise for those looking for vacancies. Providers will be able to state whether vacant beds are either available to accept a new admission, reserved or unavailable to new admissions. It is anticipated these changes will go live later this month, but a more precise timescale will be communicated.

Do I Need to Take any Action Ahead of the Changes?

Yes. To make sure everything runs smoothly, please take a minute to check...

1. That 'Maximum Capacity' minus 'Vacancies' equals 'The total number of residents today'

2. 'The total number of residents today' is not greater than 'The number known to have had the FIRST DOSE of the COVID vaccination in the UK'.

NHSX Tablet Scheme for Care Homes

We have sent communications to the care homes we understood received iPad's in winter 2020 through national scheme run by NHSX to support remote consultations for residents with health services, and communication with families. It has been confirmed that support for these devices will cease after **30 June 2022**. This means that you will need to take the actions detailed in the FAQ's, or any data (including photos, messages and apps) will be erased and the device factory reset. Providers can keep the devices but there is an option to return if you prefer. For further information or queries please contact: <u>ipad.offer@nhsx.nhs.uk</u>

Please note this does **not** affect the devices from the CCG tablet scheme- Where providers were allocated Samsung Tablets in spring 2020. Support for these devices has been agreed for until March 2024.

Enhanced Health in Care Homes Framework (EHCH) Refresh Regional Workshop

When: Tuesday 14th June, 10:00 – 11:30

NHS England and Improvement are hosting a North East and Yorkshire wide workshop, which may be of particular interest for those from general practices who work with care homes.

They are inviting people to share your thoughts on what they can improve and add to the Enhanced Health in Care Homes (EHCH) Framework. The NHS Long-Term Plan made a commitment to the national roll out of the EHCH framework to all care homes in England by 2024. A key priority for the EHCH programme this year is to refresh the framework to ensure we capture the different ways of working that the pandemic enabled and best practice from these changes; and to ensure recommended best practice in the framework is up to date.
