#### **Hot Weather and Heatwave Information**

In anticipation of the very warm weather expected this week, we ware resharing the below links and guidance that can help providers plan and be prepared for a heatwave.

- The <u>Heatwave Plan for England</u> aims to prepare, alert and prevent people from the preventable health impacts from severe heat in England.
- <u>Supporting Vulnerable People Before and During a Heatwave</u> (Guide for Health and Social Care Staff) This is part of a national programme to reduce the health risks by alerting people to the dangers and encouraging them to plan what to do in the event of a heatwave.
- Supporting Vulnerable People Before and During a Heatwave (Care
  Homes Managers and Staff)- You should read this if you work in or
  manage a care home, where people are especially at risk during a
  heatwave. This link outlines the roles and responsibilities required at each
  level.
- Beat the Heat- Staying Safe in Hot Weather: This document will tell you
  how to stay safe in hot weather, including how to keep your home cool. It
  tells you who is at greatest risk of ill health from the heat, how to recognise
  when you or someone's health may be affected, and what to do if you or
  someone else becomes unwell as a result of the heat.

### Capacity Tracker Update- COVID Vaccination Autumn Changes

We have been notified that the below changes will be made to the Capacity Tracker from September, to help support the <u>Autumn COVID-Booster campaign</u>. A reminder that for **all** providers it is now mandated to complete the Capacity Tracker regularly as a statutory responsibility from Health and Care Act 2022, as well as the information being continued to be used by local authority and health partners to support providers.

#### The following questions will be **removed**:

- Numbers of care home residents, directly employed care home staff, agency staff in care homes, and domiciliary care staff who are known to have received a first dose of the COVID vaccination in the UK
- Numbers of directly employed care home staff and agency staff in care homes self-certifying as being fully vaccinated abroad
- Numbers of care home residents, directly employed care home staff, agency staff in care homes, and domiciliary care staff who are known to have received a booster of the COVID vaccination in the UK
- Numbers of care home residents who are known to have received a 2nd booster of the COVID vaccination in the UK

#### These questions will be **replaced** with:

- Numbers of care home residents, directly employed care home staff, agency staff in care homes, and domiciliary care staff known to have received a full primary course of the COVID vaccination (For most people a full primary course is defined as 2 doses of COVID vaccination)
- Numbers of care home residents, directly employed care home staff, agency staff in care homes, and domiciliary care staff known to have received an Autumn booster\*.



# **Check Care Staff's Data Security and Protection Competency: New Tools**

In order to complete the Data Security and Protection Toolkit (DSPT), care providers need to demonstrate that their staff have been trained and are competent in data security and protection.
