Suspension of Routine Asymptomatic COVID-19 Testing in Adult Social Care

Please find through this <u>link</u>, new guidance coming into effect from **Wednesday 31 August**. At this time, whilst prevalence of COVID-19 is relatively low, staff should no longer conduct regular asymptomatic staff testing. Some staff without COVID-19 symptoms may be asked to undertake testing as part of rapid response testing for care homes and high-risk extra care and supported living services, or as part of outbreak testing in care homes. At this time, it is not recommended that staff should conduct any further asymptomatic testing beyond these situations.



COVID 19 Vaccination and Flu Vaccination Update

Further information will be communicated to providers around the upcoming winter vaccination programme, but please find information below giving an overview of current plans nationally and eligibility criteria.

- COVID-19 autumn vaccination programme planned start 5 September with gradual increase in capacity with all sites expected to be vaccinating by 19 September
- Flu vaccines are ordered and delivered directly to GP practices and pharmacies and orders will start arriving early September
- Co-administration of covid and flu vacc is recommended (if eligible) and will depend on availability of stock
- Covid programme due to be completed by early December
- Flu vaccination can continue usually until February

<u>COVID 19 Autumn Booster Eligibility</u> (Primary objective is to augment immunity in those at higher risk from COVID-19- There the following groups should be offered a booster vaccine)

- Residents in a care home for older adults and staff working in care homes for older adults
- Frontline health and social care workers
- · All adults aged 50 years and over
- Persons aged 5 to 49 years in a clinical risk group, as set out in the Green Book
- Persons aged 5 to 49 years who are household contacts of people with immunosuppression
- Persons aged 16 to 49 years who are carers, as set out in the Green Book

Flu Vaccination Eligibility:

- All children aged 2 or 3 years on 31 August 2022, and all primary school aged children (from reception to year 6)
- Secondary school-aged children (focusing on years 7, 8 and 9 following the primary school vaccination visits with any remaining vaccine being offered to years 10 and 11, subject to vaccine availability later still in the season)
- Those aged 6 months to under 65 years in clinical risk groups
- Pregnant women
- Those aged 65 years and over. later in the season; those aged 50 to 64 years old not in clinical risk groups (including those who turn 50 by 31 March 2023).
- Those in long-stay residential care homes

- Carers
- Close contacts of immunocompromised individuals
- Frontline staff employed by the following types of social care providers: registered residential care or nursing home; registered domiciliary care provider; a voluntary managed hospice; provider; Direct Payment (personal budgets) or Personal Health Budgets, such as Personal Assistants



Registering as a Priority Service or Customer with Utility Companies

Following recent service continuity events such as storms and burst water mains it has been identified that a number of care settings are not registered with their utility companies as a priority service/customer. As a result, when an incident occurs which does not trigger a multi-agency major incident response utility companies use their priority customers information to prioritise a response and not information from other agencies. Therefore, support offered to care settings may be delayed and they would be included in the response to the wider public, which could lead to a lengthy wait before any action is taken. Free Health and Social Care Workers Winter Vaccines Resources- Deadline to Order

Public Health England have made available a range of free resources including stickers, posters and Q&A flyers designed to support health and social care staff in accessing COVID-19 and flu vaccinations this winter. Capacity Tracker- COVID and Flu Vaccination Questions

As you will be aware, whilst COVID-19 and flu continues to circulate this Winter, the Capacity Tracker will continue to be the system used at both national and local level to understand uptake of COVID-19 and flu vaccinations and support providers accordingly. As such, the questions to record this information will change as below from **05 September**. As always you're support in completing these questions is greatly appreciated, so we can identify any providers needing further assistance to access vaccinations.

Care Homes: (Applying to Residents, Directly Employed Staff and Agency/Bank)

- Number known to have received a full primary course of the COVID vaccination
- Number known to have received an Autumn booster (the Autumn Booster will refer ONLY to those delivered on or after 5 September 2022)
- Number known to have received this season's flu vaccination. Please restrict flu vaccine responses to the those that are delivered between September 2022 and March 2023 (inclusive)

Home Care: Providers will now be asked to provide the same information (as above) about staff only.

A full primary course does not include COVID boosters. For most people, a full primary course is defined as 2 doses of COVID vaccination. For a small number of people, however, including people who were vaccinated abroad, people who have received a single-dose vaccination such as Janssen, or people who are severely immunosuppressed, a full primary course may mean a different number of doses.
