#### **Testing on Discharge from Hospital Guidance**

Following discussion at last week's Partners in Care Forum, we're just resharing the <u>current guidance</u> with regard to testing on discharge from hospital.

If an individual tests negative for COVID-19 and has no symptoms of COVID-19 and is being discharged to a care home from a location in the hospital where there

was an active outbreak, they should be isolated for 10 days from the date of admission to the care home, regardless of whether their overnight hospital stay was planned (elective) or unplanned. This is to prevent possible introduction of infection into the care home. Information about hospital outbreak status should be provided as part of the discharge process. Individuals who are isolating for this reason and who are able to participate in daily testing may have lateral flow testing from day 5 (counting the day of admission to the care home as day 0). They can end isolation after 2 consecutive negative tests 24 hours apart, or after 10 days' isolation if they remain asymptomatic.

During isolation, residents should be enabled to receive one visitor at a time (this does not need to be the same visitor throughout the isolation period) and have access to outside space to assist rehabilitation if possible.



### COVID-19 Autumn Booster and Flu Vaccination Access for Social Care Staff

All frontline health and social care staff are eligible for this year's vaccination programme, which remains the best way to protect yourself and those in your care and vital in breaking the chain of infection. There are several ways in which staff can access free COVID-19 and flu vaccines across this autumn and winter. Where possible and supplies allow, providers are endeavouring to provide both vaccinations simultaneously this year.

- For staff working in care homes- where supplies allow, vaccination teams will be able to vaccinate staff at the same time as residents.
- Askham Bar Vaccination site in York is open to walk in's from (open 8:00-20:00 daily) Please bring you work ID as this is available for health and social care staff only. The site can be busy so please factor this in if you are visiting.
- Alternatively you are able to book an appointment for Askham Bar or other local sites (We know many of you have staff from Leeds, Scarborough, Hull and the wider area) through the <u>National Booking System</u> or by calling 119.
- Citywide Pharmacies across York are offering both COVID-19 and flu vaccinations. To book your appointment please follow this link-https://www.citywidehealth.co.uk/
- Other local pharmacy chains across the area also offering flu vaccination, and you can book appointments via their website.

Please encourage your staff to book in for a vaccination as soon as they are able, it will make an invaluable difference in keeping people well and supporting yourselves and our local health and care system operate during the difficult winter period. #### **Capacity Tracker- Mandatory Submission Window**

A reminder that this week is the Department of Health and Social Care's mandatory submission window, where **ALL** CQC registered care homes and domiciliary care services must complete the Capacity Tracker at least once in the period **8th-14th of each month**. This information is used at ministerial and national level to understand the pressures on the care sector. A reminder that providers are still asked to complete daily where possible, and thank you to all of you for continuing to update. The information make a vital difference in sourcing care packages in and help get people back into their own home and out of hospital.
