The level of pressure on the entire system continues to increase and this communication is shared with you following what has been an exceptionally challenging weekend.

Can we please ask that on receipt of requests for admission into care and residential facilities that you have arrangements in place to consider these with the highest level of urgency, preferably on the same day wherever possible; whether it is to accept or decline.

Expediating this part of the process and reaching decisions quickly will help the whole system with patient flow through our acute and community bed bases.

Oral Health in Care Home Residents Presentation and Slides-Resources for Staff

Health and Social Care Worker Seasonal Flu and COVID-19 Vaccinations

Health and care services face a challenging winter and, as we enter the colder months, we could face a twin threat from flu and COVID-19 with both viruses in greater circulation.

Health or social care professionals are more likely to be exposed to both viruses, which can be dangerous and even life-threatening. Up to one in four healthcare professionals can get infected with the flu virus during a mild season and flu is

now circulating at higher levels than recent seasons. This is why frontline professionals are among millions who can get a further dose of the COVID-19 booster and the flu vaccine this season.

To help our hard-working frontline professionals find out why they need these vaccines and how to get them, our seasonal vaccination toolkit has been updated to inform conversations about both vaccinations. It includes tailored messages for a wide range of professional groups and a host of creative content encouraging staff to get both vaccinations. The updated content is available on the Campaign Resource Centre which includes material local sites can order. Please continue to share these resources with your networks.

Social Care Providers

Social care services face a challenging winter and are likely to experience significant staff and capacity pressures in the coming months. The people who work in health and care are of course our most important asset and encouraging them to get vaccinated will help keep services resilient during winter, and minimise staff pressures, as well as keeping frontline professional and those they care for safe.

Frontline social care professionals are more likely to be exposed to the flu and COVID-19 viruses, which can be life threatening, and they can pass these viruses on without knowing to people who may be at greater risk. Please do continue to remind colleagues come forward for both of these winter vaccinations if they have not already.

Frontline social care professionals should be encouraged to book the COVID-19 vaccine through the <u>National Booking Service</u>, by calling 119, or using <u>the online vaccination walk-in finder</u> through a simple self-referral process. Social care providers should ensure that all frontline social care professionals in their employment are offered every opportunity to receive a flu vaccine at work this season via an occupational health vaccination scheme. Where a scheme does not exist, encourage staff to book their vaccine through their GP surgery, local pharmacy or the flu national booking system.

Please encourage your staff to get vaccinated as soon as possible.



Capacity Tracker- DHSC Mandatory Submission Reminder

A reminder to all CQC registered care homes and providers of domiciliary services, that the window will be opening this window for the mandated Department of Health and Social Care submission through the Capacity Tracker.

All providers must complete the tracker at least once between the 8th and midday on the 14th of the month as condition of registration. There are potential fines as a last resort for providers who do not update- so please be mindful of this. Further information on how the regulations will be enforced can be found through this Link. A reminder this doesn't replace the need for more regular (preferably daily) usage to allow local authority and health partners to support providers. Launch of the Oliver McGowan Mandatory Training eLearning

The training has been co-produced, trialled with over 8300 health and care staff and independently evaluated. The training is now a requirement for all health and social care staff.

Funding Available- Implementation of Digital Social Care Records and Sensor-Based Falls Technology (Available to Care Homes)

The Digitising Social Care programme is a place based approach, with funding to be used for delivery and care home digitisation. This funding will support increasing digitisation within social care by enabling the adoption of care technologies that will enhance the quality, safety, and efficiency of social care. This is solely for the implementation of new Digital Social Care Records

from a supplier on the NHS Assured Supplier List and Sensor-Based Falls Technologies. Ongoing costs will need to be picked up by providers.

In order to be eligible for the funding providers need to engage with the DREaMS Team, if they haven't already, to establish their current Digital Maturity Level. Providers will then be issued an application form to request funding for a product supplying quotes to ensure validity. There will then be an approval process and upon successful applications the provider will have to sign a contract before release of funding, it has an agreement to ensure an invoice is submitted after implementation. This will prove appropriate spend and will provide transparency and auditable trails of expenditure and outcomes.

Immedicare Training-December

The latest virtual training sessions available from Immedicare can be accessed through this <u>link</u>. These are designed for both registered and non-registered staff from any service who utilises the Immedicare Telemedicine service. Sessions coming up include Verification of Expected Death, End of Life Care, UTI's, Nutrition and Hydration and Catheter Care.

Helping to Improve Access to Cancer Screening for People with a Learning Disability

Marie Kotzur from the University of Glasgow is looking for paid and family carers in England to take part in an interview. The researchers are offering participants a gift card of £30 as a thank you for giving their time. The study aims to understand the experience of screening for breast, bowel, and cervical cancers among people with learning disabilities, how their access to screening can be improved, and what could make cancer screening easier for people with learning disabilities.

The researchers are keen to speak with carers who support women with learning disabilities aged 25 to 75 years and/or men with learning disabilities aged 60-75 years. The interview can be by telephone or video call and the interviews will last between 30 and 60 minutes.
