### Community Pharmacy Bank Holiday Opening Times Rota - May 2023

### Freestyle Libre Flash Glucose Monitoring Systems- Training and Support Available

An increasing number of individuals in our care will be in receipt of Flash Glucose Monitoring equipment which allows monitoring of glucose levels without a finger prick test. For those settings with residents with the Freestyle Libre system, the manufacturer are offering bi-monthly training sessions available to staff which will guide through the basics of using the devices and interpreting the results. #### Community Services (Specialist and Core) Across Whitby, Scarborough, Ryedale and Pocklington. New Single Point of Contact (SPOC) for Humber Teaching NHS Foundation Trust Community Services

On 18 April 2023, the contacts for all GPs, patients, carers, social services, acute trusts and all other Community Service users in Whitby, Pocklington and Scarborough and Ryedale merged into a Single Point of Contact for the Trust's Community Services. This change will provide a SPOC for all neighbourhood care teams. The refined process will:

- •Provide an improved service for both patients and staff, and a greater continuity of care
- •Deliver increased referral efficiencies within a single referral protocol

## Data Security and Protection Toolkit (DSPT)- Don't Forget to Resubmit

For those care providers yet to complete the DSPT for 2022/23- the deadline to do so is **30 June 2023**. The DSPT is a self-completion assessment for providers showing what the requirements to demonstrate you are keeping people's information safe, and to protect your business from the risk of a data breach or a cyber-attack. It demonstrates compliance with GDPR/Data Protection Act/CQC KLOE's and is a requirement for all providers holding an NHS Standard contract, as well certain local authority contracts.

If you have previously completed you will need to review and resubmit. There is local support available including training workshops guiding you through completing, and 1:1 support to providers in the North East and Yorkshire through an NHS England Team who can be contacted by emailing:

#### **COVID-19 Spring Booster Vaccinations**

Rachel Ainger from the ICB's Medicines Management Team gave an update on the ongoing COVID-19 Spring Booster Baccination Programme at last week's Care Connected.

- The vaccine will be offered to all residents of older age adult care homes
- Staff (unless in another eligible group such as being immunosuppressed) are not eligible this time
- Vaccination will be offered usually by PCN (GP practice) or community pharmacy provider
- There is no need to defer immunisation in individuals after recovery from a recent episode of suspected or confirmed COVID-19 infection. Vaccination can be offered if clinically well.
- Vaccine offered will be VidPrevtyn Beta (0.5mL mixed dose) OR Comirnaty Original/Omicron BA.4-5 (0.3mL dose)
- Consent for vaccination follows usual procedures

During care home outbreaks, vaccination of residents with confirmed COVID-19 can proceed, provided that individuals are clinically stable and infection control procedures can be maintained. These populations are likely to be highly vulnerable and this approach facilitates vaccination without the need for multiple visits

The VidPrevtyn Beta Vaccine contains squalene, an ingredient derived from fish. To date, no Covid-19 vaccine offered by the NHS to the public has contained any animal ingredient, including egg. Those giving consent for a vaccination as part of the Spring campaign should be asked about any religious or ethical dietary considerations before vaccination, in order that they receive the appropriate vaccine.



#### **Menopause Awareness Training**

This training is available to access free for all individuals working health and social care across Humber and North Yorkshire- Both those experiencing menopause and those playing a vital support role. The sessions focus on what menopause is, why and when it happens and ways of managing menopause. Participants will also gain confidence in having supportive conversations around menopause and how to get the right support together including the important role a partner, team or family member can play in supporting someone through menopause.
