## What is co-production?

'a way of working, whereby everybody works together on an equal basis to create a service or come to a decision which works for them all' (Think Local Act Personal)

Related terms: Personalised, personcentred, strengths-based, working together, co-creation, user-led the support and services received, or when groups of people get together to influence the way that services are designed, commissioned and delivered'. (Care Act 2014 statutory guidance)

### Nice idea in theory...

2023 Social Care Institute for Excellence (SCIE) survey identified:

- Concerns that co-production isn't always inclusive, not all communities are involved
- Senior leaders had a better knowledge of co-production (95%) than those working in direct care delivery (41%)
- Time, organisational culture, cost and communication reported as key barriers for social care staff
- Co-production can be seen as a 'box ticking exercise'











## **Top tips: Making it work**

- Clearly communicate reason for involvement and define roles and responsibilities
- Inform and train
- Manage expectations about what can realistically be achieved
- Invest enough time and resources allow for more time than you think you need!
- Identify those that have no voice be proactive in reaching out to them
- Make it as easy as possible to get involved and contribute



### **Success in Practice**

Peerfest is an annual event that celebrates peer support. It's developed and led by those with lived experience, in partnership with Mind and other organisations. It brings people together to have fun, network and share best practice. It also includes awards for community groups doing excellent work.

Get Yourself Active aims to help people with disabilities be more active, in a way that suits them. Funded by Sport England and led by Disability Rights UK (run by disabled people), the programme is committed to embedding co-production across the sport sector to give those with disabilities more control over how physical activity is provided.

### **Engagement Planning – Service Development Team**











### **Background**

Service Development had a number of ways of engaging with the Care Market prior to the Pandemic including specific engagement events, these engagement events covered all topics and were open to all providers working with Health & Adult Services. These Engagement events were on a locality basis completed quarterly and were an in-person event.

Previous reviews of Provider engagement have been undertaken by different Teams within HAS including Quality Improvement Team (2018), and a recent review was also completed by representatives from North Yorkshire Council and Humber & North yorskhire Integrated Care Board. The most recent review involved an initial survey and sought views from the care market.

The outcome from this survey was to continue with the Care Connected virtual sessions being run jointly by North Yorkshire County Council and NHS Humber and North Yorkshire Integrated Care Board, this will allow providers to come together to hear all relevant updates across both health and social care at the same time and avoid having to attend multiple meetings.











### **Next Steps**

Care Connected gives the care market a single point of contact to hear about recent developments that affect the whole care market in a single virtual forum. Service Development will continue to support these forums, however, there is a necessity to interact with the care market in different ways and so Service Development are reviewing how it interacts with the care market in a more diverse way with different communication methods as opposed to just a virtual forum.

Through the survey results there was a request for smaller more locality based forums and this is the area that Service Development feel requires further discussion to complement Care Connected, and provide further engagement regarding our transformation plans. This will give specific forums for Providers to interact with Service Development around its plans for the future outside of the Market Position Statement and other published documentation.











### **Next Steps**

The aim is for the Service Development Team to ensure engagement at all levels, including the reintroduction of local surgeries which will be expanded to all service provider types with involvement from Quality & Service Continuity and Contract Management Teams and wider HAS support teams as required (e.g. Finance Teams). This will provide regular surgeries for Providers to raise concerns/issues that they have with how HAS works in general, with the care market, but will also ensure that Providers have a contact person who can support them to engage with the HAS.











### **Next Steps**

Explore further the re-introduction of wider Engagement Events/Forums for specific pieces of transformation work which could include but not limited to the following transformation programmes:

- Planning & Performance (Data & Intelligence)
- Cost of Care
- Residential & Nursing Strategy
- Non-regulated care transformation
- Reimagining Homecare
- Communications and stakeholder Engagement
- Supported Living
- Housing solutions

We need a mix of virtual and face to face events to ensure we can engage and capture all the views of Providers. We would use the forums as a consultation tool for innovation, collaboration and market shaping.









### Recommendations

- Re-introduce locality based Provider Surgeries, to allow Providers the opportunity for individual discussions
  around issues they are faced with, this would require involvement from Service Development Team, Quality &
  Service Continuity and Contract Management Teams and wider HAS support teams as required (e.g. Finance
  Teams). Potential for 6 surgeries a year in each locality.
- Explore further the re-introduction of Engagement Events/Forums (Transformation Forum) for specific pieces of transformation work. Suggestion is that these forums would focus on the transformation work rather than aiming the engagement at specific types of providers. No specific timetable for frequency as this would be dependent on the transformation work, but suggestion would be to use months that do not contain provider surgeries.
- Create a table of engagement for the financial year to ensure engagement is planned properly with a clear agenda and expected outcomes in advance of the transformation forum. Potential for an Engagement Plan on a Page.
- Review engagement with the ICG, potential for joint engagement with Providers, not just ICG members the larger national care providers rarely join the relevant local authority market representative group due to the administrative burden.
- Explore the benefit of having a specific forum of the benefit of the bene









### **Further Development Proposals**

- Engagement within HAS particularly with Care & Support how can Service Development better engage with other HAS staff.
- Engagement with the General Public how can Service Development better engage on their transformation work more generally.
- identify a strategic lead to champion forums.
- Create a market engagement plan to include the use of provider engagement forums and communications.
- Identify a core group of officers who will drive this agenda forward for the benefit of Service Development.

### **Workforce Data Update**

New data, released by Skills for Care, shows that between 2022 - 2023, an additional 20,000 new roles were filled in the adult social care workforce. The research also shows the job vacancy rate decreased to 9.9% compared with 10.6% in the previous year. International recruitment is also on the rise in the care sector, with around 70,000 people recruited from abroad into direct care provision roles. This increased level of recruitment has contributed to the rate of new starters across the sector rising from 32% to 34%.to find out more click here











### **Guidance and Information**

The Department for Work and Pensions and Department of Health and Social Care have published a consultation on ways to increase uptake of Occupational Health provision. Employers will be encouraged to take up Occupational Health offers to help employees access mental and physical health support at work, particularly for those working in small and medium-sized enterprises.

The proposals include introducing a national "health at work" standard for all employers to provide a baseline for quality Occupational Health provision, which includes guidance, an option to pursue accreditation, and additional government support services. The consultation also seeks views on developing longer-term workforce capacity to help meet any increased demand for Occupational Health services in the future.

NICE (the National Institute for Health and Care Excellence) published guidance on supporting adult carers in 2020. This advice remains relevant and timely today.

The guidance seeks to improve the lives of carers, and the cared for, by helping care colleagues identify needs and, then, signpost to services and resources which can help them to live and care well.

**Healthcare Provider Selection Regime Consultation:** This consultation sought views to help develop the regulations for the proposed Provider Selection Regime (RSR) and was supplementary to <a href="NHS England's earlier consultation">NHS England's earlier consultation</a> on proposals previously set out for the PSR.

This supplementary consultation opened on 21 February 2022 and closed on 28 March 2022. In total, it received 124 responses – of these, 68% were from organisations and 32% were from individuals. ### **COVID Testing for Individuals Discharged to Care Homes**

We're sharing a reminder that there is still an expectation as per national guidance that individuals being discharged into a care home from hospital should have an LFD test completed within the 48 hours prior to discharge. The relevant exert from guidance can be found below.

Individuals being discharged from hospital into a care home should be tested with a COVID-19 LFD test within 48 hours before planned discharge. This test should be provided and done by the hospital. The result of the test should be shared with the individual and their key relatives or advocate. The relevant care should be provided within the hospital before the discharge takes place. Evidence of a negative LFD test result should be communicated by hospitals to care homes in writing within the usual communications provided at the time of discharging a patient to a care home. Individuals who test positive for COVID-19 can be admitted to the care home if the home is satisfied they can be cared for safely. Individuals who are admitted with a positive test result should be kept away from other residents on arrival and should follow the guidance on care home residents who test positive for COVID-19. The period individuals should stay away from others is from the day after the positive test and does not restart when the individual is admitted into the care home. If the individual has already tested positive before the planned discharge, they do not need to test again if they continue to have symptoms of a respiratory infection and feel unwell or have a high temperature.

Where providers experience any issues around this we would have encourage you to escalate through their usual routes the discharging ward, and to the ICB if still not resolved.













# IPC Bulletin: To Dip or Not to Dip? UTIs in Those Over 65 years OR Catheterised Adults

The Community Infection Prevention Team have produced their <u>latest bulletin</u> covering whether to use dipsticks to aid diagnosis of a urinary tract infection (UTI).

Whilst this test has some diagnostic value in those who are aged under 65, it becomes more unreliable when the resident is over 65 years of age. In fact, residents over 65 years of age are more likely to have bacteria present in their urine which is not causing any infection. This is called asymptomatic bacteriuria. By 80 years of age, half of older adults in care, and most with a urinary catheter, will have bacteria in their bladder/urine, but not have a UTI. The bacteria in the bladder produce an enzyme which turns nitrates into nitrites which shows as positive on the dipstick. The positive dipstick result happens if the person has a UTI and if they have asymptomatic bacteriuria so does not help you diagnose a UTI if the person is over 65 or if they have a catheter.
